<u>Del Bartlett</u>

I joined TCHA in 1964 because of my interest in locating the site of Fort Ouiatenon. Back then we had a Fort Ouiatenon Committee of which I was a member and eventually chairman until I left Lafayette in 1968 to serve in the Navy. From 1964 until 1968 I conducted field research and historical research until we located the Site of the fort and eventually worked with The Indiana Historical Society and Dr. Jim Kellar from the IU Glenn Black Laboratory to organize and conduct the first archaeological investigation at the site in the summer of 1968. In 1967 I co-chaired the first public Feast of the Hunters' Moon as a fundraiser for further archaeological investigations at Fort Ouiatenon. Following my time with the Navy and attending law school, I returned to Lafayette in 1978 and have served as a member of the Board of Governors since. In 2016 my son, Colby, and I began a collaboration with The Archaeological Conservancy to seek grants and other funding to create an archaeological and nature preserve around the site of the original Fort Ouiatenon. With the generous help of the Indiana Bi-centenniel Nature Trust, The Indiana Heritage Trust, The Archaeological Conservancy and the Roy Whistler Foundation, The Ouiatenon Preserve has now been established as a 200 acre plus buffer around the old fort site. The preserve itself contains over a dozen other archaeological sites associated with Fort Ouiatenon and has been designated a National Historic Landmark by the U.S. Department of the Interior. I am a past president of TCHA and maintain an active role as a board member and contributing member of the Ouiatenon Preserve Committee of TCHA and other corporate committees. I would like to continue my service as a board member as we continue to expand and develop trails and an interpretive program for the Ouiatenon Preserve.

Monica Casanova

Monica Casanova is the Fairfield Township Trustee. She was elected to the office in 2022. Monica quickly reopened the office and has provided more financial assistance in one year than the previous four years combined. Monica has increased transparency by posting board agendas, minutes, and financial statements on the Township's website. Monica has reestablished trust in the community after a previous tumultuous and fraught administration whose Trustee was convicted of financial malfeasance.

Monica has a Bachelor's in Education with a focus on Social Studies education. Monica also has two Masters degrees in Public History and Library Science. Currently, she is completing a third Master's degree in Social Work. She hopes to graduate in Spring 2026. Currently, she serves on the board for Food Finders, Indiana Township Association, Area IV, and Carey Home.

Monica has a diverse personal and professional background. She was born in Mexico and migrated to Indiana from California in the early 1990s. She was part of the big surge of Latino immigration to Lafayette. She is a first generation high school and college graduate. After graduating with her MLS, she worked as a public librarian for the Monticello Public Library and was promoted to Library Director after four years. After five years as Library Director, she accepted the position of Public Services Manager for the Allen County Public Library. She has also worked for Lafayette Urban Ministry as the Assistant Director to the Immigration Clinic and later as Case Manager for Valley Oaks Health.

By joining the TCHA board, I hope to increase visibility of the Latino immigrant community to Lafayette, increase diversity on the board, and its programming. I want to promote local history and make it accessible to all of Lafayette.

H. Kory Cooper, PhD

I am an Associate Professor who joined the Department of Anthropology at Purdue University in 2008 and also hold a courtesy appointment in the School of Materials Engineering. I joined the TCHA Board of Governors in 2019 and would like to be considered for a third term. One of my main activities since joining the TCHA Board has been to serve as the Chair of the Ouiatenon Preserve Committee. Ashima Krishna is Clinical Associate Professor in the John Martinson Honors College. Prior to joining the Honors College, she was Associate Director of the Purdue Policy Research Institute and Assistant Professor of Practice in the Global Studies Program in Purdue's College of Liberal Arts. She is an architect and historic preservation planner whose research spans the management of historic urban landscapes and adaptive reuse of religious historic structures and landscapes, with a particular focus on intersection with community development and equity issues and their resulting policy challenges. Dr. Krishna has examined issues related to historic preservation planning and urban conservation in United States and India and continues to highlight the ways in which the historic built environment can be preserved, managed, and planned for. Her published work has been featured in *Journal of Urbanism, Preservation Education and Research, Change Over Time*, and *Journal of American Planning Association* among others. Her co-edited book *Heritage Conservation in Postcolonial India: Approaches and Challenges* was published by Routledge in 2020. Her current book project is an interdisciplinary examination of Asian American places of heritage in collaboration with Dr. Nathan Swanson.

I am an architect, historic preservation planner, and urban planner by training, with nearly twenty years of experience in this field in both professional and academic settings. I am a TCHA member and patron, and in the last four years of living in this community, have made extensive use of the incredible resources at TCHA, and introduced my students to them as well.
